Residential- Tennyson Center for Children's Residential Treatment program provides 24-hour care for children who cannot function in a home environment. The residential staff helps the children resolve past traumas and develop new skills to manage emotions and solve problems. Tennyson Center also offers short-term stabilization services to children and families during a mental health or behavioral crisis in the Special Services Unit when an inpatient admission is not required.

4b (Code:) (Expenses \$ 3,520,673. including grants of \$) (Revenue \$ 3,470,411.) Education and Day Treatment- Tennyson Center for Children's Day Treatment program serves children who live at home but may need more individualized schooling as they recover from abuse or neglect, or they may have mental health or developmental issues. Tennyson Center operates a kindergarten through 12th grade school that is approved by the Colorado Department of Education and accredited by AdvancED, an accreditation that promotes the learning, growth and development of children.

4c (Code:) (Expenses \$ 1,543,793. including grants of \$) (Revenue \$ 1,171,429.) Community Based Family Services- Tennyson Center for Children's Community-Based Services (CBS) are intensive in-home programs providing therapeutic services in the child's home and community between two and thirty hours per week. This program serves the entire family and focuses on emotional and behavioral challenges, mental health concerns, case management, family preservation, reunification and preventing out-of-home placements. Tennyson Center's CBS team also offers bilingual, culturally-relevant services to Spanish-speaking families. Tennyson Center's CBS is also piloting two satellite offices, one in El Paso County and one in Weld County.
