




# 4.0 DATA



### STABILIZING

Stabilize children and families to prepare for therapy. We strive to do what's best for kids and families — always.



### HEALING

Teach each child tools and strategies to overcome their unique trauma, promote coping, healing, and hope.



### REINTEGRATING

Provide families and children with the necessary tools to reintegrate back into healthy habits and communities.

## COMMUNITY BASED SERVICES (CBS)



**100%** of children remained in their homes; **100%** of children maintained school placement; **89%** of children did not have police contact while in treatment; **100%** with no punitive police contact; **89%** of children did not utilize hospitals; and **92%** of children were not admitted to hospitals.



**67%** of children demonstrated overall improved functioning according to CANS assessment. **67%** of children whose trauma stress symptoms improved according to CANS assessment.<sup>2</sup>



What we're working on:  
The number of children that maintained school placement **12, 24, 36 months** post-discharge; and The number of children maintained in their homes **12, 24, and 36 months** post-discharge.

### KEY HIGHLIGHT

**100%** of CBS children remained in their homes

#### Why we think this is important:

1. For our children that we serve in Adams county, we have now gone two straight quarters in a pandemic (April – September) without a single child being removed from the home.
2. A child remaining in home means less trauma for the family and more stabilization for the child, that is what we strive for at Tennyson.

## CAMPUS SERVICES



**100%** of children did not have police contact while in treatment; **100%** with no punitive police contact; **91%** of children did not utilize hospitals; and **91%** of children were not admitted to hospitals.



**20%** of children demonstrated overall improved functioning according to CANS assessment. **20%** of children whose trauma stress symptoms improved according to CANS assessment.

**50%** of children who exited to a permanent family or family like placement.<sup>3</sup>
