Dear Tennyson Community,

In our 121st year of serving Colorado children and families, your compassion and partnership continued to elevate our determination that everyone should have the opportunity and support needed to learn, grow and thrive. This year, we continued to strengthen our programs, advance our services, and deepen our impact – so children and families could receive the mental health care and stability they need and deserve.

While the needs of the children we serve are becoming more complex, our commitment to providing intensive, individualized support has never been stronger. Thanks to our dedicated staff, volunteers, interns, and leadership, the mental health and wellness of nearly 1,000 children and families were improved in fiscal year 2025.

Other accomplishments include growing our facility school and day treatment program by 37% in school census, from serving 46 children in FY24 to 63 in FY25. We expanded our age range to include up to 21-year-olds with our new Transition Readiness, Employment & Engagement (TREE) program addition.

TREE helps young adults with intellectual and developmental disabilities (IDD), many of whom are managing mental health needs, transition to a more independent life by building skills, confidence, and a strong support network — an essential foundation for long-term stability & well-being. We combine academics, job training, independent living skills, and therapeutic services so young adults with IDD can complete high school, explore post-secondary options, find meaningful work, and participate in all aspects of community life.

Also in 2025, Tennyson became Site Certified in the Neurosequential Model, demonstrating our ongoing commitment to ensuring that our treatment integrates the core principles of neurodevelopment with the emotional, social and psychological impacts of trauma — because trauma-informed care must align with how the brain develops and heals. This approach allows us to deliver more effective, individualized interventions that lead to better long-term outcomes.

Our school principal Djuana Osby, who has been with Tennyson for 36 years, is a two-time recipient of the Colorado Association of Family and Children's Agencies' (CAFCA's) Excellence in Education Award, most recently in 2025, and our clinical day treatment team received a TEAM Excellence Award. Djuana also received the Kaleidoscope Administrator Award from the Colorado Department of Education for exemplary leadership in supporting students with complex needs.



In addition, 35% of our students who were with us for six months or more, made progress in reading and more than 50% of our students made progress in math— critical gains that build the foundation for long-term success. Our goal is to help each child return to their community school, and this year, seventeen students successfully transitioned back to their community schools — an important milestone that reconnects them with peers and support while helping them apply skills for greater independence and growth.

Tennyson expanded outpatient services for children and adults of any age with clinicians who specialize in trauma, attachment, parenting, family dynamics and intensive case management. We bring therapy, parenting support, and behavioral services directly into homes, schools and community settings — where families are most comfortable and can take real steps toward healing. Our community-based services support a wide range of needs — from specialized care for children with autism and other disabilities to guidance for parents navigating mental health and behavioral challenges — ensuring every family has the tools they need to move forward together.

We are deeply grateful for the loyalty of our community as we continue to respond to a changing environment that calls for innovation, flexibility, and a deep commitment to serving children with the greatest needs.

OLI’S STORY

From an early age, it became clear that Oli was developing differently. While many milestones came easily to other children, he experienced challenges—especially in navigating social situations. His family began searching for a learning environment that could support both his emotional well-being and educational needs. That search led them to Tennyson Center for Children.

Rather than focusing on deficits, Tennyson Center recognized Oli’s strengths and individuality. “They didn’t see Oli through a lens of what was wrong,” his mother, Megan, shared. “They saw someone who was smart, complex, and worth understanding—and that shift changed everything.”

At a time when Oli’s family felt overwhelmed and uncertain, Tennyson Center provided not only services, but also reassurance. “It felt like someone had finally stepped in and said, ‘You don’t have to do this alone,’” Megan said. The staff took time to truly understand Oli, using careful observation and patience to identify the tools and language that would support his success.

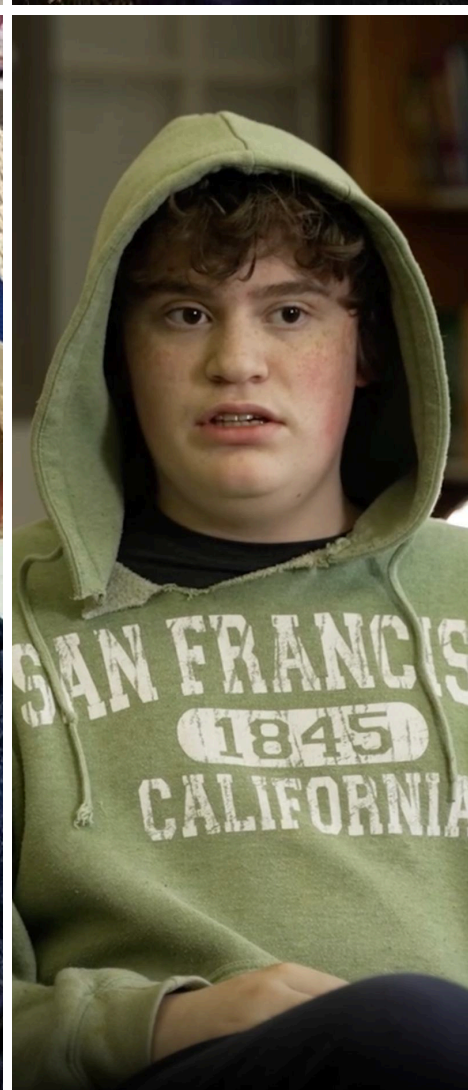
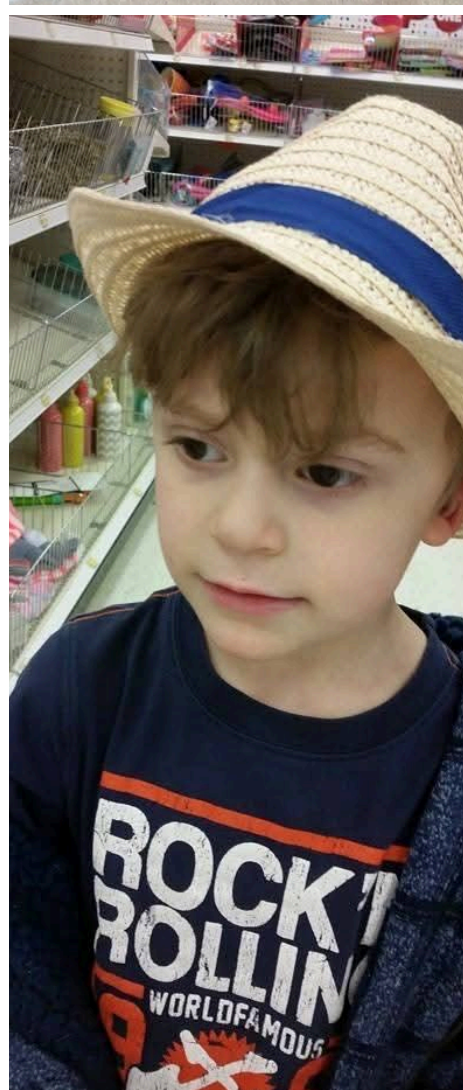

Today, Oli is thriving. He attends a traditional high school, participates in sports, and is building a sense of belonging within his community. His journey reflects the impact of tailored support and a strong network of care.

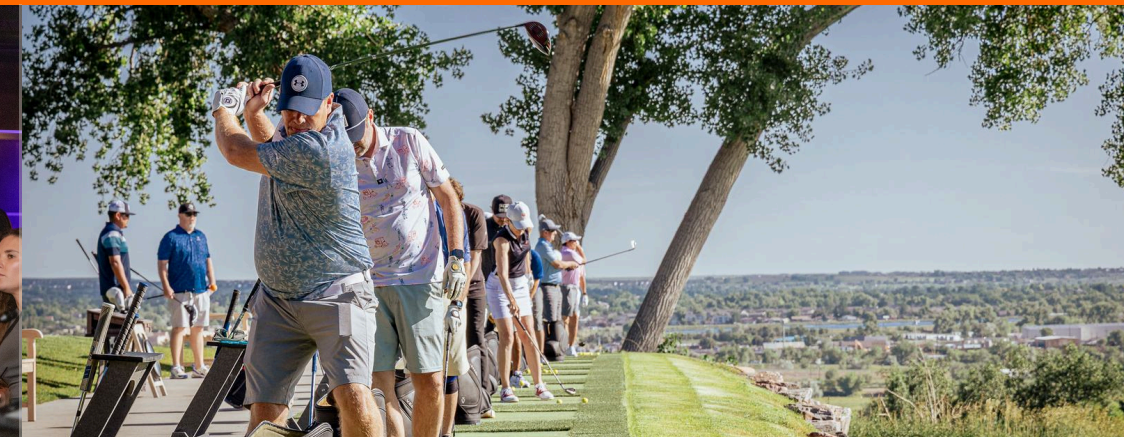

Paths to Healing Spring Luncheon

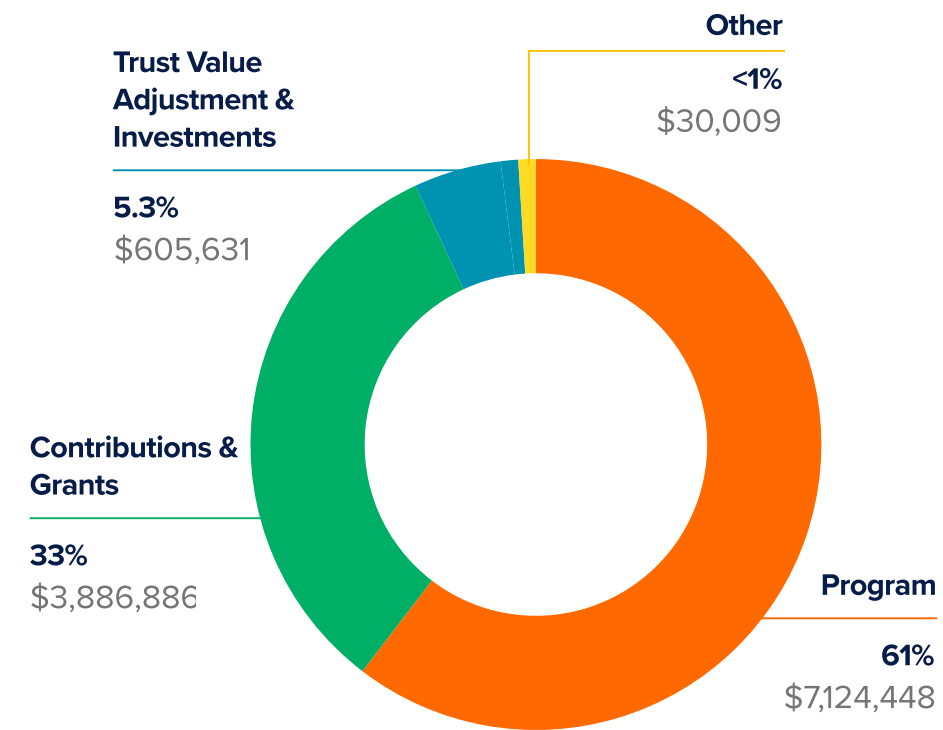
